Requirements:

Group rates are based on a minimum of 10 people (ages 7+), without exception. Rates are only available when group reservations are made at least 72 hours in advance. Rates are not available during the following holiday periods of the 2009-2010 season: **December 19, 2009 – January 3, 2010 & February 13-21, 2010.**

Fees & Deposits:

- A non-refundable deposit of 25% of the total amount is due at time of reservation to guarantee rates.
- Guaranteed attendance / final count due 72 hours prior to event date.
- Prior approval is required for the guaranteed attendance to exceed the "maximum number of people". You will be charged for the guaranteed attendance number (the count we have 3 days prior to the function) or for the actual number in attendance, whichever is higher. No allowances are given. No refunds are given if less people attend the date of the visit.
- Diamond Peak holds the right to change the quoted price for all ski/snowboard products if the group number drops below 10 people and the group has been given a discount. Rack charges will apply to all DP products if group attendance drops below 10.
- Grand total of all event fees and charges is due seven-(7) days before the day of the event, unless other payment arrangements have been made prior to the event. Delinquent balances are subject to late charges at the rate of 2% per month.

Assumption of Risks:

I understand that there are certain inherent risks in skiing and snowboarding that are an integral part of these sports, whether natural, man-made or man-modified, as defined in Washoe County Ordinance 864 which includes but is not limited to: changing weather conditions, variation or steepness of terrain, snow or ice conditions, structures and their components, collision with other skiers or snowboarders or obstacles, loading and unloading, fall from lifts, and skier's or snowboarder's failure to ski within their own ability. I further understand that participation in the sport of skiing and snowboarding may be exposing me and my group to these risks which could result in bodily injury, death, and/or property damage, and I assume these risks.
